# **Product description:**

Lecta® Lettklinker 4/10 lightweight expanded clay aggregate (LWA) is a porous, ceramic material made from natural clay. Organic matter is mixed into raw clay, which is pelletized, dried and heated in a rotary kiln at about 1150 °C. The process expands the material into granules with 5x times the volume of the original clay. The unsorted output material is sieved and blended into different grades of products, followed by distribution in bulk og in big-bags. Leca® Lettklinker 4/10 has a grading of 4-10 mm and 290 kg/m3 dry bulk density.

## **Product specification**

This EPD describes the performance for the production of Leca® Lettklinker 4/10 lightweight expanded clay aggregate, grading 4/10 mm, produced at Leca Rælingen in Norway.

#### Intended use:

The primary uses for Leca® Lettklinker 4/10 is as thermal insulation layer, drainage material, LWA masonry blocks, LWA in site-poured lightweight concrete and as soil improvement material. The material is suitable for geotechnical applications as well. Leca® Lettklinker 4/10 can also be used in water management solutions for climate adaptation purposes.

## Allocation:

The allocation is made in accordance with the provisions of EN 15804+A2. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

#### Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.



Leca® Lettklinker 4/10 is resistant to degradation, frost and high temperatures. The compound is ceramic and chemically inert.



## LCA: Scenarios and additional technical information

The following information describe the scenarios in the different modules of the EPD.

The material has an indefinite service life and require no maintenance during its utilization. Leca® Lettklinker 4/10 can be excavated and re-used in fillings in other construction projects.

Transport from production site to user (A4): Assuming 50 km transportation distance with a full size truck to the construction site. The weight of Leca® Lettklinker 4/10 is low, and the loading capacity is therefore limited by the maximum transportation volume of the truck, not its weight capacity.

## Remarks to environmental impacts

The clay is excavated from a local clay fields that are close to the factories. Consequently, the production transportation (A2) emissions and costs are minimized. After depletion all clay fields are remediated back into their original state, e.g. farmlands or natural areas.

Due to polluter-pay-principle, the emissions from waste are not included.

Biogenic carbon from biofuels are balanced to zero since they have their input and output in the same module.
